- Freight Terms: CPT USD (\$) / CPT EURO
- Terms of Payment: Letter of Credit (LC) / TT

02. VALIDITY PERIOD OF OFFERS:

Prices offered by the suppliers should be valid for a minimum period of 60 days after the closing date of quotation for acceptance.

03. CLOSING OF QUOTATIONS.

The Proforma Invoice and other required details should be sent by post or courier in a sealed envelope addressed to 'The Chairman – Procurement Committee, National Livestock Development Board No.40, Nawala Road, Narahenpita, Colombo 05, Sri Lanka by writing the title 'Importation of Pivot Sprinklers' should be written on the top left-hand Corner of the front side of the sealed envelope. Or by email to the email address nldbsupply@nldb.gov.lk on or before 08th April 2025 at 2.30 P.M (14.30 p.m) (Sri Lankan Time).

4. PROFORMA INVOICE

The Proforma Invoice should be prepared with inclusion of information mentioned in the (01) and considering the other requirements mentioned in the specifications.

5. OTHER CONDITIONS:

The Supplier should supply the required irrigation system as per the requested specification, to the buyer within 21 - 30 days after confirming the order.
